

## Women Welfare Minister Arya Reviews Preparations For World Menstruation Hygiene Day

**Dehradun:** Minister of State for Women Welfare and Child Development, Anjali Husbundry, Sheep and Goat Husbandry, Fodder and Meadows Development & Fisheries (Independent Charge) Rekha Arya reviewed the preparations for the forthcoming World Menstruation Hygiene Day programme to be held in Dehradun on May 28, during a meeting held at

Vidhan Sabha office on Monday. ## 'Ministry For Opening NE To Tourists'

**New Delhi:** The tourism ministry has proposed lifting restrictions on foreigners travelling to Arunachal Pradesh and parts of Sikkim, Minister KJ Alphons has said. Foreigners now need special permits such as a Protected Areas Permit (PAP) and Restricted Areas Permit (RAP) to be able to travel in these areas. "The ministry has proposed opening up the Northeast for tourists. In the last six months the government has opened up many restricted areas, and if the plan in the Northeast works, then many more border areas can be opened up," Alphons told PTI. The ministry proposed this on

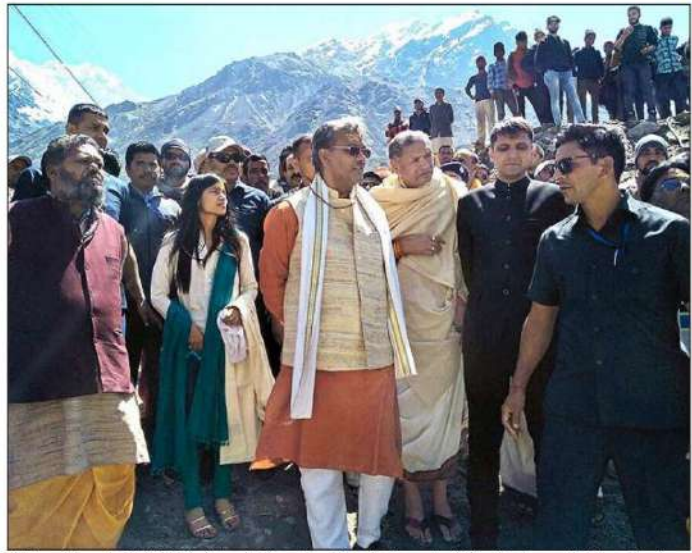
17 May at a meeting with senior home affairs and defence ministry officials. Any change would be subject to the approval of the ministries because the issue related to India's security, he said. "The states too need to be consulted and as of now we cannot give a deadline for this. However, over the past six months we have been working very fast on this," Alphons said. The tourism ministry, he added, is also planning to propose that travel restrictions be removed from border areas in Rajasthan, Uttarakhand, Jammu & Kashmir, and Himachal Pradesh. (PTI)

## Jaypee Group Founder Jaiprakash Gaur Joins JAL Board

**New Delhi:** Jaiprakash Gaur, the founder of crisis-hit Jaypee group, has joined the board of Jaiprakash Associates Ltd (JAL) as an additional director. In a regulatory filing, Jaypee groups flagship company JAL said the "board has co-opted Jaiprakash Gaur on the board of the company as an additional director with effect from May 19, 2018." 87-year-old Gaur holds a diploma in civil engineering from University of Roorkee (now IIT, Roorkee). He has

vast experience of over 64 years in the fields of civil engineering, construction, cement, real estate, expressways, hospitality and power. Gaur is already a director in some companies of Jaypee group, the filing said. Debt-ridden JAL has sold bulk of its cement business to repay bank loans. Another group firm Jaypee Infratech has gone bankrupt. Last year, NCLT had admitted an application by IDBI Bank-led consortium, seeking

resolution for Jaypee Infratech under the Insolvency and Bankruptcy Code. The tribunal had appointed Anuj Jain as Interim Resolution Professional (IRP) to manage the company's business. Bids were invited from investors interested in acquiring Jaypee Infratech with Rs 7,336 crore bid. However, earlier this month, lenders of Jaypee Infratech rejected the bid they found it inadequate. Jaypee Infratech has an outstanding debt of nearly Rs 9,800 crore, of which Rs 4,334 crore pertains to IDBI Bank. The

## Restrictions Continue In Downtown Srinagar



**Srinagar:** Curfew-like restrictions continued for the third day on Monday as a precautionary measure in the downtown and parts of civil lines and old city in Srinagar, where separatists have called for "Eidgah Chal" and general strike on the death anniversaries of Mirwaz Moulvi Muhammad Feroq and Abdul Gani Lone. On this day in 2002, gunmen also murdered another separatist leader Abdul Gani Lone founder of Peoples Conference (PC) when he was leaving Jamia Masjid in the downtown after paying tributes to the Mirwaz. Abdul Gani Lone is the father of Sajjad Gani Lone, minister in the coalition government from BJP quota and Bilal Gani Lone senior HC leader. Though police said only restrictions have been imposed, the situation on the ground was entirely different as security forces and state police personnel deployed in large numbers have closed all roads with barbed wire, directing people to remain indoors. All roads leading to Jamia Masjid were closed with barbed wire at several places, including Rangar stop, Hawal and Gowarn and by parking bulletproof vehicles in the middle. Security forces and police could also be seen deployed in the Jamia market, one of the main business hub in the downtown. UNI

## Haryana Govt To Monitor Cases Of Loss Of Stores And Public Money

**Chandigarh:** Haryana Government has directed all the Heads of Departments to prepare the list of cases of loss of stores and public money due to fraud and negligence pending in their department and finalize them after fixing the responsibility of the delinquent officers or officials. While stating this here today, a spokesman of Finance Department said that they have also been directed to send a status report indicating all such due recoveries of such kind with the latest action taken report. He said that it has come to the notice that cases of losses of store and public money arising from fraud or negligence are not disposed promptly. The cases are sent to Finance Department to write off the loss after the lapse of considerable time at the time when the delinquent officers or officials have either retired from service or died as a result of which it becomes difficult to initiate any disciplinary action against them or to effect recovery from them. The spokesman said that all the departments have been directed that all losses should be duly recorded and sanction of the competent authority to write off the irrecoverable loss should be obtained with a period of one year after fixing the responsibility of guilty persons or employees. He said that before sending the case to Finance Department to write off the loss, the first step should always be taken to fix the responsibility of the concerned employee, responsible for loss sustained by the government for fraud or negligence on his part. The officer concerned would also be held personally responsible for any loss arising from fraud or negligence to the extent to which it may be shown that he contributed to the loss by his own action or negligence in supervision, he added.
